Description of necessary first aid measures

Eye contact

Specific hazards arising from the chemical

: Highly flammable liquid and vapor. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Small spill

Large spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures
